MAINE STATE LIQUOR REGULATIONS

- May import up to 4 quarts or 1 US gallon (3.78 litres) of spirits, 3 US gallons (24 – 16oz cans or bottles, 11.35 litres) of malt liquor, and 4 quarts or 1 US gallon (3.78 litres) of wine per vehicle into the state of Maine.
- May not possess alcoholic beverages anywhere in commercial vehicles
- Must be 21 years of age to purchase or import alcoholic beverages into the state of Maine.

CUSTOMS ALLOWANCES & EXEMPTIONS AMERICAN RESIDENTS - RETURNING TO THE U.S.

DAILY

• \$200.00 USD per person. May include 50 cigarettes and 10 cigars (non Cuban) and 150ml (5 fl. oz.) of alcoholic beverages.

OVER 48 HOURS

• \$800.00 USD per person. This is a monthly exemption. Family members can combine their \$800 per person monthly import privileges.
• May include 1 Litre (33.8 fl. oz.) of alcoholic beverages or 24 bottles/cans of beer. You are also allowed to include up to 200 cigarettes and 100 cigars (non Cuban) in your exemption.

DUTY AND TAX RATES ENTERING THE U.S.

If you exceed your duty free allowance and exemptions entering the U.S., the following approximate U.S. duty and tax rates apply:

• \$2 – \$3 USD per bottle of liquor, on average • \$1.90 USD per case of beer, on average • \$10.07 USD per carton of cigarettes, on average
